All the Officers/Officials of the Regional Office, Patna are hereby informed that the remittance of fees through **online mode** is being implemented. A detailed letter in this regard is enclosed herewith and is to be circulated to all the concerned stakeholders via email without delay.

It is hereby directed that the Demand Drafts (DD) and Indian Postal Orders (IPO) will be accepted only up to 20.08.2025. No payments in the form of DD/IPO will be accepted under any circumstances after this date.

The following sections are instructed for strict compliance and adherence to this directive regarding online payments:

1. Receipt & Issue (R&I) Section

If any DD/IPO receives after 20.08.2025, the same must be forwarded along with all the enclosures to the concerned section but not to the Account Section.

2. Accounts Section

No DD/IPO is to be accepted for the purpose of issuing receipts after 20.08.2025 as all the payments will only be accepted through online mode only.

3. Examination, M&M and Other Sections

If any DD/IPO receives after 20.08.2025, it must immediately be returned to the stakeholder along with a covering letter, requesting for payment through the prescribed online mode only. These sections must maintain a proper record of all DD/IPO received, for reference in case of future queries/information or clarifications.

All the concerned officers are directed to ensure strict adherence to these instructions to facilitate smooth implementation of the online payment system.
